Because a Use Variance runs with the land, the current landowner so an applicant, to be Board of Appeals that:  1. Under applicable zoning regulations,	it may not be granted to ease the personal difficulties of entitled to a Use Variance, must demonstrate to the the applicant cannot receive a reasonable return from
any permitted use from the property	in question, which difficulty must be established by

- competent financial evidence. Proof must be given that the land in question cannot yield a reasonable return if used only for a purpose allowed in that zone.
- 2. The use applied for will not alter the essential character of the locality. Changes would not disrupt or alter the character of the neighborhood, or a district, so as not to be at odds with the purpose of the zoning ordinance.
- 3. The hardship is unique as to this parcel and is not general throughout the zoning district.

There must be proof that a particular property suffers a singular disadvantage through the operation of a zoning regulation and not to general neighborhood conditions before a variance thereof can be allowed on the grounds of "unnecessary hardship".

4. Demonstrate that the hardship is not self-created.
